The Serbian Radiation and Nuclear Safety and Security Directorate, 41a Terazije Street, Belgrade (hereinafter referred to as the Directorate), pursuant to Article 136, Paragraph 1 and Article 141 of the Law on General Administrative Procedure ("Official Gazette of the RS", number 18/16 and 95/18 – authentic interpretation), Article 22, Item 8) of the Law on Radiation and Nuclear Safety and Security ("Official Gazette of the RS", number 95/18 and 10/19), in consideration of the Application submitted by "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, dated 6 December 2024 and registered under number 532-01-877/2024-03, for the issuance of a Licence for the performance of a radiation activity, on 27 February 2025, renders the following:

DECISION

ON THE ISSUANCE OF LICENCE FOR THE PERFORMANCE OF A HIGH-RISK RADIATION ACTIVITY

1. "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, is hereby allowed to perform the high-risk radiation activity of trade in radiation sources with storage, categories I and II.
2. "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, shall perform the high-risk radiation activity of trade in radiation sources with storage, categories I and II, through the following organisational unit: **OJ Spoljnotrgovinski promet (OU Foreign Trade Transactions)**.
3. "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, 11351 Belgrade, can store I and II category radiation sources in the warehouse, in accordance with the conditions stated in Safety Report number I-VR-PRI12-398/23 dated 29 November 2024



and in Ionising Radiation Protection Programme number P-VR-PRI12-398/23 dated 29 November 2024, prepared by an authorized legal entity for the preparation of safety reports and ionising radiation protection programmes of "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade.

4. "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, shall apply general principles of responsibility and fulfil the obligations of a Licence holder in accordance with the law, other special laws, regulations and acts regulating the field of radiation safety and security.
5. The Decision on the Issuance of Licence for the Performance of a High-Risk Radiation Activity is valid for a period of three years from its delivery date.

6. The person appointed as a person responsible for the protection from ionising radiation shall act in accordance with Article 104 of the Law.
7. "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, can only perform the import, export or transit of radiation sources upon a previously obtained Licence issued by the Directorate for each individual trading transaction.
8. "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, shall keep records on the trade in radiation sources referred to in Item 1 of this Decision.
9. "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, shall inform the Directorate about any changes in the data on the fulfilment of requirements based on which the Institute has obtained the Decision on the Issuance of Licence for the Performance of a High-Risk Radiation Activity, within 30 days from the occurrence of changes.
10. Not later than 60 days before the expiration of the validity period of this Decision, "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, shall submit to the Directorate an application for the extension of the validity period of the issued Decision. The validity of the Licence for the performance of the activity of trade in radiation sources referred to in Item 1 of this Decision shall be extended by the same period for which Licence has been granted.



Statement of Reasons

On 6 December 2024, "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, submitted the Application for the issuance of a Licence for the performance of the radiation activity.

Along with the Application for the performance of the radiation activity, the following documents were also submitted by "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade: evidence of registration, Safety Report number I-VR-PRI12-398/23 dated 29 November 2024 and Ionising Radiation Protection Programme number P-VR-PRI12-398/23 dated 29 November 2024 prepared by an authorized legal entity for the preparation of safety reports and ionising radiation protection programmes of "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, evidence of the ownership in the business premises, Certificate of the Appointment of a Person Responsible for Ionising Radiation Protection prepared with the use of Form P04-05, a list of exposed persons prepared with the use of Form P04-06, evidence that individual monitoring of exposed employees has been provided, a list of radiation monitors and measuring equipment, report on ambient dose equivalent testing with assessment of the exposure of exposed employees and population and with an opinion on the fulfilment of the requirement regarding the prescribed measures of protection from ionising radiation of the space in which radiation sources are stored until their handover to an end user, Plan for acting in case of emergency, Approval to the Safety Plan obtained from the Ministry of the Interior, as well as evidence that an integrated management system has been implemented, maintained and applied.

The radiation activity to be performed by "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street, Belgrade, referred to in Item 1 of the operative part of this Decision, has been determined as a high-risk radiation activity, in accordance with the provisions of Article 33 of the Law and in accordance with the Rulebook on the Conditions for Categorization of Radiation Activities ("Official Gazette of the RS", number 94/19, 133/21 and 30/22).

Based on an insight made into the documentation appended to the subject matter Application, it has been established that the requirements are fulfilled as prescribed by the provisions of Article 34, Paragraphs 1 and 2, Article 35, Article 36, Article 38, Paragraph 1, Article 41, Article 196, Article 197 and Article 240 of the Law on Radiation and Nuclear Safety and Security ("Official Gazette of the RS", No. 95/18), Article 5 of the Rulebook on the Conditions for Obtaining a Licence to Perform a Radiation Activity ("Official Gazette of the RS", No. 61/11, 101/16 and 50/18) and by the Decision on the Determination of Goods the Import, Export and Transit of Which Require the Acquisition of Specific Documents ("Official Gazette of the RS", number 92/17, 29/18, 56/18 and 78/18), and that to "Vinča" Institute of Nuclear Sciences, Institute of National Importance for the Republic of Serbia, University of Belgrade, 12-14 Mike Petrovića Alasa Street,



Belgrade, a Licence can be issued for the performance of the high-risk radiation activity – trade in radiation sources with storage, categories I and II.

The fee for the issuance of this Decision is not charged pursuant to Article 18 of the Law on Republic Administrative Fees (“Official Gazette of the RS”, No. 43/03, 51/03 – correction, 61/05, 101/05 – other law, 5/09, 54/09, 50/11, 70/11 – reconciled RSD amounts, 55/12, 93/12, 47/13 – reconciled RSD amounts, 65/13 – other law, 57/14 – reconciled RSD amounts, 45/15 – reconciled RSD amounts, 83/15, 112/15, 50/16 – reconciled RSD amounts, 61/17 – reconciled RSD amounts, 113/17, 3/18 – correction, 50/18 – reconciled RSD amounts, 95/18, 38/19 – reconciled RSD amounts, 86/19, 90/19 – correction, 98/20 – reconciled RSD amounts, 144/20 and 62/21 – reconciled RSD amounts, 138/22, 54/23 – reconciled RSD amounts, 92/23, 59/24 – reconciled RSD amounts and 63/24 – amendments to reconciled RSD amounts).

LEGAL REDRESS: This Decision is final and no appeal can be made against it, but an administrative dispute can be instituted within 30 (thirty) days from the Decision delivery date.
